Form of Contract

THIS AGREEMENT made the 20th day of APRIL 2026 between *Ministry of National Health Services Regulations & Coordination (M/O NHSR&C), Islamabad* of Pakistan (hereinafter called "the Procuring Agency") of the one part and *Abbott Laboratories (Pakistan) Limited of Karachi, Pakistan* (hereinafter called "the Supplier") of the other part:

WHEREAS the Procuring Agency invited Bids for certain goods and related services, viz., *Anti-HCV Rapid Diagnostic Testing (RDT) Kits* and has accepted a Bid by the Supplier for the supply of those goods and related services in the sum of *PKR 207,350,000/- (Rupees Two Hundred Seven Million Three Hundred Fifty Thousand Only)* (hereinafter called "the Contract Price").
