THIS AGREEMENT made on the 20<sup>th</sup> April of 2026 between Elimination HEP-C, M/o NHSR&C, 3rd Floor, Kohsar Block, Pak Secretariat, Islamabad. of Pakistan (hereinafter called "the Procuring Agency") of the one part and Roche Pakistan Limited (Diagnostic Division) of [Karachi and Pakistan city and country of Supplier] (hereinafter called "Roche Pakistan Limited") of the other part:

WHEREAS the Procuring Agency invited Bids for certain goods and related services, viz., [Polymerase Chain Reaction (PCR) Kits for Prime Minister program for Elimination of HEP-C Infection] and has accepted a Bid by the Supplier for the supply of those goods and related services in the sum of 124,525,960/- in words One hundred twenty-four million, five hundred twenty-five thousand, nine hundred sixty. hereinafter called "the Contract Price".
